Hazardous Drugs Compliance Program

▶ SERVICE DESCRIPTION:

This program provides (a) customized policies, procedures, and forms for pharmacists to comply with USP <800>, (b) creation of Hazard Communication Plan and (c) access to training and training materials. Client will have access to this program through the Compliance Portal^(R). There will be no hard copy deliverables.

▶ SERVICE TERM:

An initial one-year term is required. The initial term will begin on the date of the first invoice to Client and will end 12 months thereafter ("Initial Term").
